(Aligned with Saudi Ministry of Education Regulations & IB PYP Standards)

## 1- Purpose

The purpose of this policy is to establish clear expectations for student behavior that foster a safe, respectful, and positive learning environment in accordance with the Saudi Ministry of Education regulations and the MGIS mission, vision, and values. It also outlines the procedures for handling misbehavior in a consistent, fair, and developmentally appropriate manner.

## 2- Policy Statement

MGIS is committed to promoting a culture of respect, responsibility, and integrity. All students are expected to demonstrate behavior that reflects:

- Islamic values and Saudi cultural norms
- The IB Learner Profile attributes
- Respect for others, property, and the learning environment
- Responsibility for actions and choices
- Safe, positive, and cooperative conduct

Any behavior that disrupts learning, threatens safety, or goes against school or Ministry guidelines will be addressed promptly using clear and appropriate disciplinary procedures.

# 3- Guiding Principles

- Respect for Saudi MOE laws and regulations regarding discipline, safety, and conduct.
- Consistency and fairness in handling behavior incidents.
- Child protection and safeguarding in all disciplinary actions.
- Developmentally appropriate responses, especially for KG and young learners.
- **Positive reinforcement** is the foundation of discipline.
- **Restorative practices** that teach responsibility rather than punish.
- **Communication with parents** is essential for student growth.

# 4- Expected Student Behavior

Students are expected to:





- Follow school rules and staff instructions
- Demonstrate polite, respectful language and manners
- Maintain appropriate behavior in classrooms, hallways, playgrounds, buses, and school facilities
- Respect Islamic values and adhere to Saudi norms
- Take care of school property and avoid vandalism
- Behave safely and avoid physical or verbal aggression
- Complete academic responsibilities honestly (no cheating or plagiarism)
- Use digital devices responsibly and safely
- Stay within school boundaries and follow dismissal procedures

# 5- Types of Misbehavior (Aligned with MOE Categories)

## 5.1 Minor Misbehaviors (Level 1)

## Examples include:

- Disrupting lessons or talking without permission
- Not following class routines
- Running in hallways
- Lack of materials or uniform violations
- Inappropriate language (non-offensive)
- Not completing classwork
- Minor disrespect or non-compliance

# 5.2 Moderate Misbehaviors (Level 2)

#### Examples include:

- Repeated disruptions
- Defiance or refusal to follow instructions
- Disrespect towards peers or staff
- Intentionally damaging school property (minor)
- Bullying (first incident)
- Using a device inappropriately
- Pushing, rough play, or unsafe physical behavior

# **5.3 Major Misbehaviors (Level 3)**

## Examples include:

- Physical aggression/fighting
- Threatening behavior





- Repeated bullying
- Significant damage to property
- Stealing or dishonesty
- Academic dishonesty (cheating, plagiarism)
- Leaving class or school premises without permission
- Inappropriate digital use (harassment, harmful content)

# **5.4 Critical Misbehaviors (Level 4 - MOE Serious Violations)**

## Examples include:

- Possession of prohibited items (weapons, harmful objects)
- Severe physical assault
- Severe vandalism
- Ethical or legal violations
- Any behavior threatening safety, security, or values
- Any violation listed as serious misconduct by the Saudi MOE

# 6- Discipline Procedures

## **6.1 For Minor Misbehaviors**

Handled within the classroom using:

- Verbal reminders or redirection
- Positive reinforcement
- Reflection time
- Seating adjustments
- Classroom restorative conversations
- Teacher-student conference

**Documentation:** Recorded in social worker's notes if repeated.

## **6.2 For Moderate Misbehaviors**

Escalation to Principal or Social Worker:

- Parent notification
- Written behavior note/incident form
- Short supervised reflection time
- Logical consequences (e.g., repairing damage, apology letter)
- Temporary loss of privileges
- Behavior improvement plan

**Documentation:** Formal incident report filed by the social worker in school records.





# 6.3 For Major Misbehaviors

Escalation to Academic Head or Deputy Head:

- Parent meeting required
- Behavior contract
- Mandatory counseling with social worker
- Community service inside school
- Temporary suspension in accordance with MOE regulations (if applicable)
- Restorative conference

**Documentation:** Social worker writes an immediate report; parents sign acknowledgment.

## 6.4 For Critical Misbehaviors (MOE Level 4)

Handled according to MOE regulations with full administrative and legal compliance:

- Immediate removal from class
- Investigation by social worker and school leadership
- Mandatory parent conference
- Documentation submitted to MOE if required
- Suspension or other disciplinary actions as per Saudi MOE policy
- Behavior rehabilitation plan

**Documentation:** Official MOE reporting template (if mandated).

# 7- Positive Behavior Support (PBS)

MGIS promotes positive behavior through:

- IB Learner Profile recognition
- Class points or reward systems
- Certificates, praise notes, and monthly awards
- Restorative circles and conflict-resolution strategies
- Social-emotional learning (SEL) sessions
- Counseling and skill-building support

# 8- Roles & Responsibilities

#### **Students**

- Follow all rules and behave respectfully
- Take responsibility for actions
- Demonstrate the Learner Profile attributes





#### **Teachers**

- Establish a positive classroom climate
- Teach expectations clearly
- Manage minor misbehavior in class
- Document incidents and inform parents when required

## **Principals & Social Worker**

- Provide support, mediation, and behavior coaching
- Oversee moderate behavior cases
- Writes and compiles all related reports and documents

## **Principals & Academic Head**

- Oversee implementation of the policy
- Manage major and critical incidents
- Communicate with MOE when required

#### **Parents**

- Reinforce school expectations at home
- Attend meetings when behavior concerns arise
- Support intervention plans

## 9- Communication With Parents

Communication will be clear, timely, and documented through:

- Educore
- Email
- Phone calls
- Parent meetings
- Incident reports
- Behavior contracts (if needed)

# 10- Prohibited Items (MOE-Compliant)

## Students must not possess:

- Weapons or sharp objects
- Tobacco, vapes, or any prohibited substance
- Matches or lighters
- Any item threatening safety or morality
- Unauthorized digital devices or content





## 11- Restorative Practices

To repair harm and rebuild relationships, the school uses:

- Guided reflection
- Apology letters
- Restorative circle meetings
- Peer mediation
- Counseling sessions

# 12- Record Keeping

All behavior incidents must be:

- Logged in the school's digital platform
- Stored securely per MOE and school data compilation strategy
- Attached to the student's file when required

## 13- Policy Review

This policy will be:

- Reviewed annually by the Technology Committee
- Updated to reflect curriculum changes, software updates, safety requirements, and school needs
  - Communicated to all staff and parents after each revision
